

REACH Summer Camp Scholarship Policy

Scholarship Eligibility

Families qualify for scholarship if their annual or weekly household income matches a cell in the table below.

Families must provide valid proof of income within one week from the time registration is completed.

Each student is eligible to receive scholarships for **two camp sessions per summer**. Students can enroll in additional camp sessions for full price, or be added to a scholarship waitlist. To be added to the waitlist, then contact us at 517-999-3643 or sofia@reachstudioart.org. If additional scholarships are still available, you will be notified before the start of camp. Scholarships are not available for extended care options.

Attendance Policy

Scholarship recipients **must** attend a minimum of 50% of classes to remain eligible for future scholarships. If a student is absent for more than 50% of a program's duration, **the family will be ineligible for scholarships the following term**. REACH staff will do their best to accommodate unavoidable cancellations due to illness or major emergencies. REACH reserves the right to revoke future scholarships for any reason.

Acceptable Documents as Proof of Income

Proof of income is due **within one week of completing registration**; or scholarship price will be voided, and registration cancelled.

Acceptable documents include:

- Most recent IRS Form 1040 (pg 1, line 9)
- A copy of an EBT card with holder's name
- Recent pay stub

Proof of income can be submitted to family's ACTIVE account, emailed to sofia@reachstudioart.org or physically provided during REACH hours (a photo will be taken then uploaded to family's ACTIVE account). Proof of income information is valid for one calendar year (Fall - Summer).
